**BACKGROUND:** Due to rapidly deteriorating fire conditions due to low humidity, unusually high temperatures and extreme blowing and gusting winds across the county, Commission Chairman, with the request of Cascade County's Disaster and Emergency Services Director and the majority of rural fire chiefs, enacted Stage 1 Fire Restrictions in Cascade County on December 3, 2021. That act was ratified by the full Board of County Commissioners on December 14, 2021.

Thereafter, with a substantial change in fire conditions and the majority of partner agencies and rural fire chiefs agreeing that emergency fire restrictions were no longer warranted, Chairman Briggs rescinded the Stage 1 Fire restrictions on December 28, 2021, pursuant to Resolution 21-80. Passage of Resolution 22-06 will be a ratification by the full Board of County Commissioners of the December 28, 2021, rescission of the emergency State Fire Restrictions.

**RECOMMENDATION:** Approval of Resolution 22-06 Ratifying the Rescinding of the Emergency Enaction of Stage 1 Fire Restrictions.

**WHEREAS**, on December 3, 2021, the rapidly deteriorating fire conditions due to low humidity, unusually high temperatures and extreme blowing and gusting winds across the county were significant contributing factors and have caused Cascade County’s Disaster and Emergency Services Director and the majority of the Rural Fire Chiefs to request Cascade County to move into Stage 1 fire restrictions; and,

**WHEREAS**, all three commissioners concurred with the request of the implementation of Stage 1 fire restrictions; and,

**WHEREAS**, Commission Chairman Joe Briggs did authorize that Cascade County move into Stage 1 Fire Restrictions immediately on December 3, 2021; and,

**WHEREAS**, the Board of Cascade County Commissioners on December 14, 2021, did affirm and ratify the action taken by Chairman Briggs to enact and impose Stage 1 Fire Restrictions; and

**WHEREAS**, fire conditions having changed substantially and the majority of our partner agencies and rural Fire chiefs concurred that the Stage 1 fire restrictions were no longer warranted; and

**WHEREAS**, all three commissioners concurred with that the emergency conditions that existed to implement the Stage 1 fire restrictions no longer existed; and

**WHEREAS**, the Board of Cascade County Commissioners were advised that the burn permit process was available to mitigate weather and wind conditions as may be warranted; and

**WHEREAS**, Commission Chairman Joe Briggs did authorize pursuant to **Resolution 21-80** the rescission of the emergency enactment of Stage 1 fire restrictions, effective December 28, 2021; and

**NOW THEREFORE, BE IT RESOLVED** that the Board of County Commissioners of Cascade County affirm and ratify the emergency action taken by Chairman Briggs on December 28, 2021, to rescinding the emergency enactment of Stage 1 Fire Restrictions within Cascade County.

**WHEREAS**, on December 3<sup>rd</sup>, 2021, the rapidly deteriorating fire conditions due to low humidity, unusually high temperatures and extreme blowing and gusting winds across the county were significant contributing factors and have caused Cascade County’s Disaster and Emergency Services Director and the majority of the Rural Fire Chiefs to request Cascade County to move into stage 1 fire restrictions; and,

**WHEREAS**, the Board of Cascade County Commissioners on December 14<sup>th</sup>, 2021, did affirm and ratify the action taken by Chairman Briggs to enact and impose Stages 1 Fire Restrictions; and,

**WHEREAS**, fire conditions have now changed substantially and the majority of our partner agencies and rural Fire chiefs concur that the stage 1 fire restrictions are no longer warranted; and

**WHEREAS**, all three commissioners concur that the emergency conditions that existed to implement the stage 1 fire restrictions no longer exist; and,


**WHEREAS**, the Board of Cascade County Commissioners has been advised that the burn permit process is available to mitigate weather and wind conditions as may be warranted.

**NOW THEREFORE, BE IT RESOLVED** that by Cascade County Commission Chairman Joe Briggs, as the presiding officer of the Board of Cascade County Commissioners, declares, effective immediately, that Stage 1 Fire Restrictions are hereby rescinded.

**BE IT FURTHER RESOLVED**, the copies of this Emergency Declaration be filed with the County Clerk and Recorder and the Cascade County Disaster and Emergency Services Director.
