Public comment is welcome and, as a general rule, will be limited to five (5) minutes so as to allow all interested parties an opportunity to comment in a fair and timely manner.

The public is encouraged to submit data, views, and arguments, orally or in writing for or against the proposed revisions to the Cascade County Zoning Regulations.
